CCNSG stands for Client Contractor National Safety Group and it was originally known as SCATS . The CCNSG tends to be used most in Power Generation, Steel, Oil, Gas, and Chemicals industries.

The Passport is obtained after taking two days generic health and safety training and passing some multi choice tests. We ask that you bring 3 Passport Photos and your NI Number which we use to create the CCNSG Card, on the second day of the course when you pass.

After 3 years you must get your card renewed by sitting on a 1 day renewal course. You have a window of 6 months prior to the expiry date on your card and 3 months after. If you go over 3 months, you have to sit the full course.

You can sit on a CCNSG Supervisor 1 day course to obtain the Supervisor Passport aimed at managers and supervisors. You must have an in date CCNSG Card to be able to attend.



SPA stands for Safety Pass Alliance. It has been developed for and by numerous industry sectors, including; Food, Quarry, Petrol Retail, General Manufacturing, Building Maintenance, Pharma, Construction, Ports, Logistics, Landfill, and others.

The passport is two days training. The first day is "The Core Day" providing generic Health & Safety training. The second day is Industry Specific and is written by major companies/bodies who represent the sector and the particular needs of the sector. You will need your NI Number for the course and we take a digital picture of you for the card.

You may be exempt from the first day of the SPA Course, the Core Day, if you have an existing Health & Safety Qualification (which includes CCNSG). Ask us for the exemption list when enquiring if you think you may fit the criteria.

After 3 years you must get your card renewed by sitting on a 1 day course. You have a window of 3 months after the expiry date on the card to sit the renewal. If over that you have to sit the full course.

FAQs

Question: How do I know which Passport I need? *Answer:* It is up to the Client which one they require, as it's part of their site Health and Safety policy. If in doubt you need to ask your Client. GSS Training also put up the website: www.whichsafetypassport.com to help.

Question: How much do these courses cost? *Answer:* All 2 day courses cost £155+vat, all 1 day renewals or if exempted from the Core Day cost £105+vat, all Supervisor Courses cost £125+vat.
